Sub: Collection of User Fee for Computerized certified copies issued by the Tahsildars

In order to make the computer system in Tahasils self-sufficient & sustainable, the Government had issued Resolution No. 39463 dated 23.09.2005 for collection and utilisation of user fee payable for procurement of computerized copies of RoR and various miscellaneous certificates. Further, by amending the Resolution No. 39463 dated 23.09.2005, the Government had also issued Resolution No. 38196 dated 07.09.2011 for replacement of computer hardware, augmentation of computer infrastructure etc.

As per the provisions of ORTPS Act, there is a necessity for stable internet connectivity in 317 Tahsils and 2413 RI offices for providing essential citizen centric services.

2. After careful consideration, the Government have been pleased to revise the rate of user fee for different kind of services and amend the guidelines for utilisation of user fee in the following manner.
